- O Beth Perrow will attend the June 11 inspection of primary voting equipment. We'd like someone to attend the June 14 pre-processing of mail-in ballots. Registrar Melissa Hart needs more Democrats to work inside the polls in November.

- Mary Jo is going to the Democratic National Convention in Chicago in August, having been chosen at the CD7 convention in May. Joseph Smith was chosen as a Biden Elector.
